# NEWSFLASH! YOUR PAINTING WILL BE DISQUALIFIED IF YOU BREAK THE RULES

It is important that you <u>read the Prospectus for each individual show</u> as it may vary by venue.

Here is a general checklist for acceptance:

- ☐ My painting is an original work created by me, not under instruction or copied from another artist's work. It is not a print or a giclee.
- $\ \square$  My painting including the frame fits the size restrictions shown the show's prospectus.
- □ My painting was created using one of these three entry categories:
  - Watercolor
  - Acrylic
- Mixed media consisting only of some combination of watercolor, acrylic, water based ink or water based gel mediums
- $\ \square$  My painting does not have any paper or fabric adhered to my substrate, that was not plain and has not been painted over by myself.
- ☐ My painting has not been entered in a previous PBWS show.
- ☐ My painting is presented in the following manner:
- On paper: Framed and glazed with plexiglass or varnish, and there is no writing on the mat board.
- On other surfaces if not framed must have finished edges; stretched canvas must be wrapped finished edges with no staples showing
- $\ \square$  My painting is wired firmly for hanging, with the wire ends taped and is ready to hang
- ☐ My painting has a label on the back with my Name, Address, Phone, Email, Title of painting, Media, Size & Price
- $\ \square$  I have completed my entry form and submitted a jpeg of my work by the deadline.

Take-in: Monday, March 24, 2025, from 9:30-11:00
Reception at BRiC on Thursday, March 27 from 5:00-6:30
Pick-Up: March 2026 (Note: This is a one year show!)

<u>Eligibility</u>: Artists may enter 1 <u>piece</u> of art. Minimum size, <u>framed</u> or on canvas is 16 x 20. Maximum size, <u>framed</u> or on canvas is 48 wide x 60 high. Canvas must be stapled on the back and not on the sides!

Entry Fee: \$35.

<u>Entry Rules</u>: Enter the exhibit through our website <u>www.palmbeachwatercolorsociety.com</u>, click on "shows" and pay with your credit card. You will then need to email your jpegs to Lee Krull at <u>idesign@gate.net</u>. Please include your name in the email and the title of the painting above each jpeg.

Do not show any frame or mat in the image and ensure the image is correctly oriented, either horizontally or vertically. Paintings that are not correctly oriented and/or cropped will <u>NOT</u> be accepted in the show. All artwork will be accepted into the show unless it does not meet the eligibility requirements below.

The first 50 entries will be accepted thru March 20.

Eligible Artwork: Watercolors, Acrylics, and water based Inks may be entered into the show. Water media collage made by an artist's own artwork is acceptable but newspaper, magazine or other non-water media cutouts will NOT be accepted. Heavy graphite, oil pastels, foils, buttons, string are also NOT accepted. White tissue paper, rice paper, handmade paper and washi that has been painted over by the artist is acceptable. Oils, pastels, charcoal, drawings, photography, prints or giclees will be NOT be accepted. Images should be of your original art only, and not created under instruction or copied from another artist's work. Only your own, original photographs may be used for reference. Paintings that have been exhibited in prior PBWS shows are NOT eligible.

<u>Framing Requirements</u>: Paintings on paper must be glazed with plexiglass or varnished. Glass will not be accepted. Works on other surfaces, if not framed, must have wrapped edges, with no staples showing. All work must be wired firmly, taped and ready to hang. All entries must remain hanging for the duration of the show. **BRIC will not accept artwork with carved or gilded frames or frames that are larger than 2".** 

<u>Please include the following information on the back of your painting:</u> Artist Name, Address, Phone, Email, Title of Painting, Media, Size and Price. Please tape ends of the wires in back of your painting.

<u>Judge</u>: We are pleased to announce that Patti Maguire will be judging our show. Patti's award winning work has been exhibited at the Boca Raton Museum of Art, Coral Springs Museum of Art and other venues throughout Florida and Colorado. Her paintings currently hang in both private and corporate collections.

Whether working in traditional or digital mediums, he finds joy in creating images through the improvised application of layers of color. A current favorite is using gouache for portraiture. He has demonstrated his work on the online platforms, 21 Draw and Artefacto. Jordan's clients have included Strathmore, Princeton Brushes, Sketchy, Columbia Records, Disney Plus, and Grammy nominated artist D Smoke. **JUDGE'S REMARKS**: "My overall impression: Bravo to all of the artists! Thank you PBWS. Thank you all for being bold, creative and putting yourselves into art to share with the world. I am honored to have been selected to judge this beautiful show. It is with humility I present my choices - while you may not have received an award, I hope that my explantations helps understand my reasoning. I also appreciate again as in all of my choices that I felt a personality in the artwork - they were not just and order taker but went beyond their subject to let me see a piece of their soul. Who could ask anything more from an artist and their works? This was not an easy exhibition to judge! I honestly wish I could give out 5+ more awards of paintings I thought extremely worthy of receiving one. Sadly I had to limit my choices to the following selections." – Jan Guarino



#### FIRST PLACE Anne Waters "Zen Garden"

"It starts with my own love and romance with water lilies combined with a visit to Giverney to experience Monet's garden in person. But this painting goes beyond the subject to guide the eye to experience a combination of moving back in space adding intrigue to the perspective while offering

a glimpse of foreground with the weeping branches. The use of the bright greens take us through the journey making this painting exciting, painterly and a total feast for the eye."

#### SECOND PLACE Marilyn Liedman, "The Pride of Africa"

"This piece drew me in immediately. I wanted to explore every corner of this painting - I FELT the habitat of the lions and I



wondered it was that had caught their attention. The brush strokes are masterfully done the way the light hits the landscape and the animals are settled into a shady spot that is repeated on the very top... what?? That's right on the very top and

very top and bottom are these cooler areas and it is masterfully done. I'm lost in this painting wanting to explore the wild."



#### THIRD PLACE Susan List, "We Have Roses"

"This painting could easily convert me from my beloved watercolors into trying acrylics. The use of blues, yellows and pinks to depict the white flowers only to be dramatized further with the deep greens is nothing short of sheer delight. The composition is actually quite intriguing the way the top flowers are placed and broken into the front blossoms cascading down the

center of the canvas. It works and it's so painterly - something I adore."

#### HONORABLE MENTION Lee Krull "There's One In Every Crowd"



"On first glance you can see the artists ability to control the medium with ease. Going beyond their incredible command of watercolors, the more I stayed with this painting the greater the appreciation for how the artist "bridged the palette" - using all the colors to the inside of the sunflowers adding an unexpected color

combination as well as introducing a unique pattern. I just love seeing that in a painting - how an artist can bring together all the colors into areas that it actually isn't."

#### HONORABLE MENTION Saundra Newman "Three Dog Night"

"I was so engaged with this painting because of the unique and strong composition from the top horizontal right, across to the



floral wallpaper to the gold into the strong angle of the couch completing it with the bend of her arm and hand. Even to the bright blue on the lower left. It kept my eye moving throughout the piece wanting to understand more of what the artist did to move my eye the way it did."

#### JUDGE'S CHOICE Trish Kahn "Love That Sunshine"

"From the moment I viewed this exhibition, this piece jumped off the wall and stopped me in my tracks. It spoke to me the moment I saw it. The choice of colors are both vibrant and soft -





## WATERCOLOR DOCTOR

#### Question:

I submit my paintings to various shows, but I don't seem to win awards. Should I try to paint something in the style of the judge's work, so that she will like it and maybe give me an award?

#### Answer:


Trying to paint something to please a judge is never a good idea, and I'll explain why. The first reason is that you would be compromising your own style and method of working by trying to copy someone else's. But there's a larger reason to consider here.

I have juried and judged many shows, both for entry (jurying) and for awards (judging). My work has also been accepted into well over 100 national and international shows, and I have received over 80 awards. Each time I have entered a show, whether or not my work is accepted, I have later received a color catalogue of all the accepted works, so I can see the range of paintings which were selected and the ones which have also won awards in the show. But remember that in judging paintings, or anything else for that matter, we bring our personal biases, no matter how hard we try to be objective. Yet any judge who is professional about it will recognize a high level work even if (and especially if) it is very different from her own style. In fact, work that involves different techniques or a different approach is more likely to impress a good judge than something similar to what she already does herself. In making her choices, a really qualified judge should also have a balance of styles and subject matter in the paintings she gives awards to. They shouldn't mostly be little clones of her own work. She should be able to look beyond her own personal ideas of painting.

Now keeping all of that in mind, be aware that your painting which was unnoticed or rejected from one show may well go on to win an award in another show. This isn't just a bromide; it's true! Speaking personally, there are some jurors who have always rejected my work, and I will no longer submit to shows they jury. But in contrast, the opposite has held true! I have won awards for works which never made it into other shows because the juror rejected them.

What does this tell us? We should do the very best work we can and remind ourselves now and then that it is good work. But we should always keep striving to improve and grow, by learning new things, by studying good paintings to see why they get accolades, and by staying true to our own personal vision of what we want to express with our art!
